Lakshmibai College, University Of Delhi invites Expression Of Interest (EOI) only from reputed and experienced agencies / NGOs / Colleges to run Crèche cum Day Care Centre in its campus at Ashok Vihar, Phase-III. The aim of the facility is to establish in its premises a crèche and day care centre which will provide good quality and reliable care for the children of employees of the college. To make the facility sustainable the service provider may open the admission to the children of outside neighboring areas with due approval of the Crèche Committee of the college. In any circumstance, the first preference will always be given to children of Lakshmibai College staff. The environment shall be child-friendly and educational; ensuring the holistic development of the children. Children between the age group of 6 months to 10 years can be enrolled in the facility. They shall be segregated according to their age. Age appropriate education shall be provided to the children enrolled in the day care. After-school day care services shall be available for children between 3 to 10 years of age. The agency should have at least THREE years of experience as on 1 August, 2019 to run such facility.

The Last date to submit the EOI is 11th September, 2019 at 3:00 pm. The vendors are required to submit the EOI online at email ID: eprocurement@lb.du.ac.in. No hardcopies will be accepted. The Tender will be opened on 13 September, 2019 at 11.00 AM.

1. Lakshmibai College is inviting Expression of Interest from reputed and experienced agencies / NGOs / Colleges / Individuals run a Crèche-Cum-Day Care Centre from 0830 hrs to 1830 hrs at the campus. The Lakshmibai College Campus situated on Swami Narayan Marg, Ashok Vihar-III, is a full-fledged campus with all the necessary amenities for its employees. The committee members of the College are seeking services of a professional Crèche in order to have a balance between professional and parenthood needs.

Duration of the contract period

At the initial stage, the contract shall be for a period of 1 year from the date of commencement of contract. Lakshmibai College will have discretion for extending it for one more year or more years up to a maximum of 5 years subject to satisfactory service and on mutually acceptable terms and conditions

The basic requirements are:-

- a. The agency should be a reputed and experienced agency who has demonstrated and verifiable expertise to run a Pre-school and Crèche-Cum-Day Care Centre for children.
- b. The agency should have at least three years of experience and evidence of having successfully run such a facility.
- c. Required hours of operation from 0830 hrs to 1830 hrs from Monday-Saturday and all working days at the campus.
- d. Should cater to children in the age group of 6 months to 10 years.
- e. <u>Meals are to be provided by parents only</u>. Agency will have to make sure that the children eat healthy and nutritious meals as provided by their parents, fed on time and the cleanliness of the dining area is maintained.
- 2. The EOI should include:
- a) An overview of the proposed "Crèche-Cum-Day Care Centre.
- b) Manpower Planning: Numbers, Type, Qualification and Experience of staff to be provided by agency for operating the "Crèche-Cum-Day Care Centre".
- c) Present infrastructure available with the agency and experience profile of providing/operating such facilities.
- d) Basic furniture that will be provided such as cots, mattresses, cradles, etc. and essential play material, teaching and learning aids. The furniture should be child appropriate. However, some material is available which will be handed over.
- e) Detailed plans for age appropriate activities to keep the children engaged.

f) Feedback / Recommendation about the services where the agency has worked for not less than two years.

- 3. Key Points to be noted:
- a) The agency shall not sublet / off load / entrust the whole work or any part thereof to any other person / party to carry out its obligations.
- b) The agency shall provide the required sufficient number of its own staff (FEMALE ONLY and adults who are medically fit, bearing good moral character) for rendering the services.
- c) Lakshmibai College shall provide the basic infrastructure, i.e. space, water supply, electricity etc. All responsibility of the care for children would be with the agency operating the pre-school/ day care centre.
- d) The agency would be expected to provide child development activity support for toddlers and pre-schoolers on par with the best industry standards. Details should be clearly outlined in the EOI.
- e) Lakshmibai College reserves the right to appoint a supervisor/ coordinator (individual or committee) that would periodically oversee the functioning of the day care centre and to ensure that good quality services are being regularly provided. Complete cooperation would be expected from the agency.
- f)Lakshmibai College shall not provide the accommodation for the staff being deployed by the agency.
- 4. Interested agencies may visit (with prior intimation and approval) Lakshmibai College campus in order to assess the requirements and have first-hand knowledge of the location.

 - (iii) Presentation by the agency to officials of the College. The presentation should cover the basic concept of functioning, the services offered, manpower planning and infrastructure required from Lakshmibai College.
- 11. No financials to be given by the agency at this stage.
- 13. After evaluating technical aspects the names of the suitable agencies will be recommended by the committee for inviting financial offers.
- 14. Based on the scrutiny of financial offers vis-a-vis services offered by the agency, the competent authority of the College will approve the name of the agency suitable to run Crèche cum Day Care Centre at Lakshmibai College.
